

1916 and 1924 amendments

AN ORDINANCE TO LICENSE AND REGULATE SHOWS, EXHIBITS, CIRCUSES, MOVING PICTURE SHOWS (INDOOR AND OUTDOOR), ENTERTAINMENTS AND OTHER PUBLIC AMUSEMENTS AND THE PLACES WHERE THEY ARE GIVEN.

The Board of Supervisors of the Township of Fayal do ordain as follows:

Section 1. No person, firm or corporation shall perform or assist in performing any show, exhibition, circus, moving picture show (indoor and outdoor), public entertainment, public play, amusement or performance, nor conduct, operate or maintain any theater, hall or other place where any of the performances above named are given or held, unless the same has been licensed according to the provisions of this Ordinance.

Section 2. Any person, firm or corporation desiring to procure a license for any one or more of the things mentioned in Section 1 of this Ordinance shall apply therefor, in writing, to the Clerk of the Township of Fayal, stating specifically the kind and character of the things desired to be licensed; the period of time for which said license is desired and agreeing that the applicant will faithfully observe and fully comply with all the terms and provisions of this Ordinance.

The Clerk of the Township of Fayal shall then issue such license to such applicant; provided, that such applicant shall have first paid into the Treasury of the Township of Fayal the amount of license fee required by this Ordinance, and provided that no license fee shall be required for giving any public performance or entertainment for any religious, charitable or literary purpose.

Section 3. The fees for licenses required by this Ordinance shall be as follows:

Theater in a building, \$25.00 per year;
Theater that is outdoors or a drive-in, \$50.00 per year;
Circuses or menageries, \$25.00 per day;
Merry-go-round, shooting galleries and other games and vocations of like character, \$1.00 per day;
For any opera, theatrical performance, minstrel or vaudeville show, concerts, \$1.00 per day;
For any show, entertainment, exhibition or performance of any kind not otherwise enumerated herein, \$1.00 per day.

Provided, that no license shall be required for any performance when the same is given or held in any regular established opera house, theater or hall, which is licensed under this Ordinance.

Section 4. No license under this Ordinance shall permit or suffer any intoxicating liquor to be sold or drunk upon premises where any performance licensed by the Ordinance is held or in any theater or hall licensed under this Ordinance.

Section 5. Any license issued under this Ordinance may be revoked by the Board of the Township of Fayal at any time without notice to the licensee, except a license for a regularly established theater or hall, which license may be revoked for cause after notice to the licensee and an opportunity afforded him to be heard.

Section 6. Any violation of this Ordinance shall be punishable by a fine not exceeding \$100.00, or by imprisonment in the County or Town Jail for a term not to exceed thirty (30) days.

Section 7. All Ordinances and parts of Ordinances inconsistent herewith are hereby repealed.

Section 8. This Ordinance shall take effect and be in force from and after its passage and posting.
