## LOCAL BOARD OF APPEAL &EQUALIZATION FAYAL TOWN HALL MAY 3, 2006

The Meeting of the Local Board of Appeal and Equalization was called to order at 1:00 P.M. by Chairman Kniefel. Present were Chairman Kniefel, Supervisor Beldo, Supervisor Pernu, Supervisor Branville, PUC Clerk Stewart.

Also Present were Dave Sipola, Fred Hippa, Dave Jarvela and others from the St Louis County Assessors office.

Purpose of the meeting is to hear and act on any appeals from taxpayers of the township. Dave Sipola, St Louis County Assessor explained the procedure. The Town must have a quorum and at least one must be trained. The Town has a quorum present and several Supervisors have been trained. We may proceed. The representatives from the County Assessor's office have no authority in making valuation changes at the meeting, they are only there to answer questions. It is the Town board's responsibility to conduct the business of the Local Board of Appeal & Equalization. The Town board will hear all appeals first and then make decisions and mail a letter of the action taken to the taxpayers. The burden of proof is on the owner and they need to substantiate there appeal. The book of sales was past around to the residents. After an appeal is made to the Local Board of Appeal & Equalization you are entitled to a hearing at the County Board of Appeal & Equalization which hears appeals by appointment during the last two weeks in June. Mr. Sipola reported the Dept. of Revenue will be conducting a survey after the Local Board of Appeal & Equalization. They may be calling the property owners to ask questions.

Motion by Chairman Kniefel to decrease the value of the building for William McBride 340-0000-9160, due to the building burnt down, support from Supervisor Branville. Motion carried unanimously.

Motion by Supervisor Beldo to make no changes to the value of Steven S Anderson's property 340-30-0150, due to no supporting evidence, support from Supervisor Branville. Motion carried unanimously.
