#### REGULAR MEETING OF THE FAYAL TOWN BOARD

## **JANUARY 7, 2014**

Motion to approve the minutes of the December 17, 2013 Regular Meeting, made by Supervisor Branville, support from Supervisor Pernu. Motion carried unanimously.

#### **REPORTS**

<u>Clerk/Treasurer's Report</u>- All bank statements for the month of December 2013 have been received and reconciled. Revenues for the month were \$383,682.74 and there was a transfer of \$118,553.69 from Mt. Iron Checking to Assessment savings. Expenditures were \$116,697.28. Ending balances are:
