REGULAR MEETING OF THE FAYAL TOWN BOARD

APRIL 16, 2013

The Regular Meeting of the Fayal Board of Supervisors was called to order at 7:00 PM by Chairman Tammaro. Present were: Chairman Tammaro, Supervisor Erjavec, Supervisor Pernu, Supervisor Coldagelli and Clerk Sersha. Supervisor Branville was absent.

Audience members in attendance were: Steve Shykes, Scott Smith, Jerry Ulman and Jim Johnson.

Motion to approve the minutes of the April 2, 2013 Regular Meeting, made by Supervisor Pernu, support from Supervisor Coldagelli. Motion carried unanimously.

CITIZEN CONCERNS AND COMMENTS

Jim Johnson stated as a representative on the E-V Airport, they are trying to pull the documents together to come before the board for the vacation of South Airport Road. Resolutions are also needed from Virginia and Eveleth.

Jerry Ulman recommended changing the waste site dates to May, since we still have snow. Waste site will be open Noon- 5:00 PM on May 3,4,5,10,11,12,13,17,18 & 19.

Fire Chief Steve Shykes reported the firefighters will be leaving for the conference in Indianapolis next Tuesday. Also, Engine 81 has a leak in the tank and we should look at a plan for its replacement. Discussion. Chairman Tammaro asked Chief Shykes to bring in the ISO standards for the board's review. Supervisor Pernu asked how much it would cost to replace the truck? Chief Shykes answered it would be between \$160-170,000 for a new truck.

<u>Gilbert Sewer Proposal</u>- Supervisors Erjavec and Tammaro met with Scott Neff last Friday regarding the contract. Neff and Gilbert Attorney Jackie Corradi are working together to form a contract that all parties can mutually agree upon.

Eveleth Wastewater Proposal- Nothing at this time.

Supervisor Pernu-

<u>Grader</u>- The grader is out of commission. The brakes locked up and a pressure hose blew. We are waiting for Ziegler for a repair cost estimate. For now, plowing can be handled with the trucks and loader.

Supervisor Coldagelli-

<u>Humane Society</u>- They have requested a list of dog licenses. For now, we will not look at amending the animal ordinance to include costs for housing an animal and passing that cost onto the animal owner.

New Building- The fire department would like to paint their portion of the interior of the building, and they are requesting the town to buy the paint. Labor would be free, by the firefighters. Also, flashing may need to be put around the perimeter of the floor to keep water from seeping into the walls. Electrical has also been requested. Nels Myklebust has offered to install.

Motion to renew the contract with Range Quality Pest Control in the amount of \$375, made by Supervisor Pernu, support from Supervisor Erjavec. Motion carried unanimously.

Chairman Tammaro reported Eveleth water failed the turbidity test again in February and March. Eveleth has reported they now have the problem fixed by installing more filtering media and a new coagulant pump.

Motion to support City of Virginia Resolution 13070, in opposition to the westerly route to realign US Highway 53, made by Supervisor Erjavec, support from Chairman Tammaro. Motion carried unanimously.

Motion to appoint Bruce Erjavec to the E-F Cable TV Commission for a three year term, beginning immediately, and ending December 31, 2016, made by Supervisor Pernu, support from Chairman Tammaro. Motion carried unanimously.

Motion to pay the bills made by Supervisor Pernu, support from Supervisor Erjavec. Motion carried unanimously.
