REGULAR MEETING OF THE FAYAL TOWN BOARD

SEPTEMBER 2, 2014

The Regular Meeting of the Fayal Board of Supervisors was called to order at 8:00 AM by Chairman Tammaro. Present were: Chairman Tammaro, Supervisor Erjavec, Supervisor Pernu and Clerk Sersha. Supervisor Branville was absent and Supervisor Coldagelli did not arrive until 8:15 AM. Matt Reid of SEH was also in attendance for a portion of the meeting.

Motion to approve the minutes of the August 19, 2014 Regular Meeting, made by Supervisor Erjavec, support from Supervisor Pernu. Motion carried unanimously.

REPORTS

<u>Clerk/Treasurer's Report</u>- Bank statements for August 2014 have not been received yet, so this report is tentative. Revenues were \$154,679.53 and expenditures were \$130,311.07. Tentatively, balances are:

Motion to accept the July 9, 2014 Fire Department Regular Business Meeting minutes made by Supervisor Erjavec, support from Chairman Tammaro. Motion carried unanimously.

SCHEDULED GUESTS

Matt Reid of SEH was in attendance. Bids for the IRRRB Sewer Project were opened last Thursday. Sealed bids were received as follows:

Hibbing Excavating- \$138,446.00

Utility Systems of America- \$170,267.00

One other bid was received from Subsurface Underground Construction, but no bid bond was included so the bid was not valid.

Upon tabulation of the bids, Matt Reid recommended the project be awarded to Hibbing Excavating for the low bid price of \$138,446.00. Engineer's estimate was \$136,404.50

Motion to award the IRRRB Sewer Project to Hibbing Excavators in the amount of \$138,446.00, made by Supervisor Erjavec, support from Supervisor Pernu. Preconstruction meeting will be held early next week. Should take one week to drill under Hwy. 53, project should be complete in one month, by end of October or sooner. Motion carried unanimously.

Mr. Reid reported he will check with Casper Construction regarding the Pleasant Lane Culvert Project. It will take three weeks for the pipe to get here. The road will be closed that day from 9-2. Police, fire and all residents will be informed of the road closure when the time comes.

Clerk Sersha reported a driveway was installed on a township road with no driveway or excavation permit. The resident had been provided with the forms twice and was instructed what needed to be done, but the paperwork was never submitted, nor was the \$1,000 bond paid.

Motion to turn the violation of the excavation ordinance over to Chief Thompson, made by Supervisor Erjavec, support from Supervisor Pernu. Motion carried unanimously.

Supervisor Pernu reported he tried to contact Roger Nelson of the DNR regarding burning the brush pile at the waste site, but has not heard back from him.
