Discussion- Beldo will be meeting with Earl Wilkens to see if we can reduce the costs of the project in any way. It will be re-bid as soon as possible. Motion carried unanimously.

#### Supervisor Branvile

**New Fire Truck-** The new fire truck has arrived. Supervisor

**Website-** The website has not been updated for a longtime. As long as we are paying for the website we need to keep it up to date, otherwise people will quit going to the website.

# Supervisor Pernu

**Hall Damage-** A letter was sent to Mr. Butarac saying the deposit will be held due to damage done during the estate sale. No response. Repairs are being made at this time.

**Woods by the playground**- Cleanup will continue through the summer. Chairman Kniefel talked to Jerry Birchum about the Bio Mass project. They will be able to chip the stumps. We will store the stumps from the cleanup project for Bio Mass. The test burn will be October 2006.

**Landscape in front of the building-** We will be working on it when we have the availability of workers.

**HAVA Grant-**The grant application has been submitted for one automatic door opener, the quote was for \$2,600. Beldo asks if it may be a problem only doing one door. The intent of the grant is for voter accessibility. We will see if it is problem, and deal with it then.

**Fire Dept room air conditioner-** In Aug 05 the Fire Dept. requested a window air conditioner for the meeting room, approximately \$300-\$500 at that time. Building and grounds did not have the funds at that time so, it was tabled. Frank Pavelich asked about the AC. Discussion, the fire department should have to pay for the AC out of the fire dept funds. Have them come with a current cost maybe volunteers can help.

# **Supervisor Tammaro**

**EFG Joint Cable Commission Budget-** they are asking for 15% of our budget or \$3,300. The Town paid \$2,070 this year. The joint cable commission wants 40% of the franchise fees. The PUC uses the fees for operating. The Town Board agree we should give them one more year. The cost is based on a % of the Fayal customers. The school used to pick up a big part of the budget.

Motion to fund the EFG Joint Cable commission for 2007 at the same level as 2006 for \$2,070, made by Supervisor Tammaro, support by Supervisor Beldo. Discussion- this will allow them to correct there expenditures and they will still be able to operate. Motion carried unanimously.

A new rate schedule was approved at the last meeting, Tammaro brings forward the addendum for the sewer service agreement for the City of Eveleth at the park. The board reviewed the addendum, the City will execute the normal service agreement with the addendum.
