REGULAR MEETING OF THE FAYAL TOWN BOARD

MAY 5, 2009

The Regular Meeting of the Fayal Board of Supervisors was called to order at 7:00 PM by Chairman Kniefel. Present were: Chairman Kniefel, Supervisor Erjavec, Supervisor Branville, Supervisor Pernu, Supervisor Tammaro and Clerk Sersha.

Audience members in attendance were: Steve Shykes, Dave Hartman, Jerry Ulman, DeLyle Pankratz and SEH Engineer Jim Johnson.

Motion to approve the minutes of the April 21, 2009 Regular Meeting made by Supervisor Tammaro, support from Supervisor Branville. Motion carried unanimously.

SCHEDULED GUESTS

DeLyle Pankratz was in attendance to report on the snowmobile trail. Barr Engineering has been hired. The plan is for the trail to not go under the Hwy. 132 bridge, but to go under the Hwy. 53 bridge. Approval for an easement has been tentatively obtained from a private property owner for the trail to extend from Hwy. 53 to Hwy. 132, then to the existing bike trail, and end at the town hall parking lot. Trail length would be 1.6 miles, with the construction costs running about \$2,000. Mr. Pankratz requested Fayal coordinate and be responsible for the 132 crossing, and to pay the costs for grooming and normal maintenance. Cost for grooming, at this time, is \$595 per mile. The rate is charged annually. Total annual cost should be about \$1,000 per year. Mr. Pankratz stated that signs should be placed on the trail stating no motorized use, except for snowmobiles. The trail would not be open to ATV's. Mr. Pankratz also requested that someone from Fayal be appointed to protect the town's interest. Mr. Pankratz would represent the Trailhawks Snowmobile Club.

Discussion on the 53 to 132 crossing, its construction cost, and maintenance costs. Chairman Kniefel asked if a permit has been issued for the crossing? Mr. Pankratz answered the permit has not been issued yet. Kniefel questioned if the township wants to be in the snowmobile trail business, and how the township money would flow for construction and maintenance costs of the trail. Supervisor Branville volunteered to be a representative of the township to work with the Trailhawks Club.

Motion to appoint Lee Branville as a representative of the township and coordinate with the Trailhawks on the snowmobile trail, made by Supervisor Branville, support from Supervisor Tammaro. Motion carried unanimously.

REPORTS

<u>Clerk/Treasurer's Report</u>- For the month of April 2009, there were \$46,283.49 in receipts and \$89,404.72 in expenditures. Ending balances are as follows:

Miners Bank- \$107,895.55 Assessment Savings- \$435,400.02 Mt. Iron Checking- \$648,409.22

Certificates of Deposit will be maturing this month. As of this date we have a total of \$407,136.00 invested. Current rate for CD's is 2.75%. Clerk Sersha asked for a consensus of the Board as to whether the funds should be re-invested. The Board agreed that new CD's should be purchased.

Motion to approve the Clerk/Treasurer's Report made by Supervisor Branville, support from Supervisor Pernu. Motion carried unanimously.

Motion to accept the April 2009 Police Report, made by Supervisor Branville, support from Supervisor Pernu. Motion carried unanimously.

Motion to accept the April 2009 Road & Bridge Report, made by Supervisor Tammaro, support from Supervisor Pernu. Motion carried unanimously.

CORRESPONDENCE

SLC Land Dept.- The land department is proposing the sale of tax forfeit property in the township. Location is E1/2 of W $\frac{1}{2}$ of E1/2 of SW1/4 of NW 1/4, Sec. 27. The town board may apply to acquire this land for a public purpose. Placed on file.

SLC Planning- Public hearing will be held for a conditional use permit for First Class Day Care Center, 3805 Miller Trunk Rd, on Thursday, May 14, 9:30 AM, Northland Office Center. Referred to Planning Committee, placed on file.

MN Revenue- Annual hearing on unmined iron ore assessments for the year 2009 will begin at 10 am, Thursday, May 21, Eveleth Public Library. Placed on file.

Eveleth Golf Course, K & B Drive In- Request for renewal of 2009-2010 liquor licenses. Referred to New Business.

OLD BUSINESS

Supervisor Erjavec-

<u>O'Laughlin Square Project Engineering</u>- A meeting was held with Supervisors Tammaro and Erjavec, SEH Engineers Julie Kennedy and Jim Johnson regarding the engineering on the project. Tammaro and Erjavec made it clear that the board was dissatisfied with how the project was done and that after the project was assessed, there were more outstanding invoices of which the town board was not aware. SEH has offered to give a credit of \$6,000 on future engineering costs. SEH will not write a check back to the township. Supervisor Tammaro stated that if we do a future project, the credit should go to the water company, unless it is a water project.

Supervisor Pernu-

Complex Project Plan- Nothing at this time.

Road Swap Inspection- Supervisor Pernu and Steve Verkovich inspected the roads the county is proposing to exchange with the township. Pernu reported that County Road 950 is in bad shape, is cracked and needs ditching. County Roads 389 and 654 are both gravel and Scout Camp is in good shape with good ditching, although it should be re-striped. Supervisor Pernu stated he saw no advantage for Fayal to swap the roads with the county.

Motion not to do a road swap with the county, made by Supervisor Pernu, support from Supervisor Tammaro. Pernu, Tammaro, Branville, Erjavec voted yes. Kniefel voted no. Motion carried.

Motion to piggyback with the county on the Scout Camp Road project at an estimated cost of \$25,000, made by Supervisor Tammaro, support from Supervisor Pernu. Motion carried unanimously.

NEW BUSINESS

Supervisor Branville reported that Chief Thompson has submitted a list of supplies needed by the Police Department. The supplies are under \$500 in total cost.

Motion to authorize Chief Thompson to make the purchase for the supplies needed, made by Supervisor Branville, support from Supervisor Pernu. Motion carried unanimously.

Supervisor Branville reported that we are looking into purchasing a portable radar speed sign. Branville will also obtain an estimate for taking the stickers off of the old police car, and if the cost is not too high, will see that the car is brought in.

Fire Chief Steve Shykes was in attendance and submitted five bids for an air compressor system. Funds for the purchase came from a 2008 FEMA grant, with the fire department contributing 5%. Chairman Kniefel opened and read aloud the bids, as follows:
