#### APPROVAL OF MINUTES

Chairman Tammaro reported meeting with Jordon Metsa from "Congress comes to you" he stated Gilbert is in line to get federal and state money for the sewer project.

Rich Sather states the Town Board approved making a sewer collaboration group we are looking for two PUC members. We will include 2 from each of the Town Board, council members and PUC commissioners from Fayal, Eveleth, Gilbert, and Leonidas to be on the sewer collaboration group. Cal Turner and Greg Buckley will volunteer from PUC. This group is in the making more to come.

#### **CORRESPONDENCE**

Mike Erjavec exemption form he signed in 2004 said he has no running water and no septic system it was inspected by Dale. Mike pays monthly because he took the 100'of pipe.

SCADA- IRC found the generator needs repair. Chairman Tammaro reports he is still waiting for an estimate, and they are looking into a FEMA grant.

## TREASURER REPORT

Treasurer report as of 9-30-2016 Year to date was provided by Clerk Coldagelli and reviewed by Erickson.

Fayal Sewer Company is in balance. FSC Revenues \$397,447.02 Expenditures \$402,519.78 Cash Bal. \$169,945.80. Chris notes there is \$183,000 in depreciation we don't see.

Fayal Water Company looks good. FWC Revenues \$59,571.50 Expenditures \$41,956.90 Cash Bal. \$54,628.17.

Chris notes we should look at the rate increase of \$1 to keep in line with inflation. He and Greg will review the spreadsheet for the next meeting.

#### **GAS**

Long Lake Gas Line project- They are installing meters on the houses.

Miller Trunk extension- The letter was sent there are rebates available for furnace installation.
