GUEST

Mr. & Mrs. Dan Malterud purchased property on Hwy 37 from Josephson, The Town Board granted exemption from the monthly sewer fee in lieu of cleaning the property, until July 07. 7:05 Russ Troutwine arrives.

They are requesting an extension until next spring.

- Motion by Erjavec to deny the extension, second by Damberg for discussion: because they already had one year.
- Erjavec in favor Bertucci, Damberg, Pernu, Troutwine apposed. Motion Failed.
- Motion by Bertucci to grant the extension to June 1st and bring in paperwork from the State, second by Damberg.
- Bertucci, Damberg, Pernu, Troutwine in favor, Erjavec apposed. Motion carried.

Town Supervisor Branville reports Mark Forte and Russ Troutwine requested the Town find out what it will take to connect into the force main that cuts thru their 34 acres. They assumed they had sewer access and the parcel is being split into 3 parcels, one is planning to build a house ASAP.

They were assessed. The Town board asked Julie Kennedy from SEH engineering to put together a plan. She will bring an answer to the work group meeting on Friday. 7:25 pm Tony Tammaro arrives.

Kunnari - tapped the waterline two times. We are sending a bill for the \$3,500 WAC fee x 2=\$7,000. No paperwork filed.

Motion by Damberg to send a letter to all contractors saying they must follow the rules. Damberg rescinds his motion.

Motion by Damberg to send them a ticket for working in the ROW. Died for lack of a second. Eveleth maintains that waterline so they did not violate our tapping rule they are just going to get two WAC charges.
