CORRESPONDENCE

November 2015 Water Wastewater Report. Diane reported the purchase of an ATT micro cell booster to improve the cell phone reception inside of the building. Due to the pagers being eliminated.

Delinquency Report as of 11-24-15 \$18,996. We will be certifying the October balance due. The Town Board did receive a copy of the delinquency report.

OLD BUSINESS

SCADA- TPC has completed training and installation, it appears to be working well. Lanyk still has to finish some work with the antenna cables. Erickson will check with Heidi regarding the funding for the SCADA.

Delinquency disconnects- ordinance has been adopted and published on 12-6-15. Pernu is wondering about garnisheeing wages. Turner stated when he did it, you need an attorney and go to court, he lost about 30-40% then they can fight the judgment. He felt it was not worth it. Erickson states we will change our penalty fee to 10% each and every month. And increase the rate to \$58 per month. We will double the amount we will charge for delinquent accounts until it is certified to the county. Hopefully it will encourage timely payments.

NEW BUSINESS

TREASURER REPORT

Clerk Coldagelli has provided the revenue and expenditure guidelines for the water and sewer company. Water Co. revenue of \$68,000 lots of things brought in cash but just looking at operations. Expenditures of \$57,000 you have to subtract the transfers. Chris will meet with Heidi next week, she continues to consolidate and simplify. Sewer Co. revenue of \$476,000 sewer sales and debt service. All expenses total \$448,000. Chris is thinking it should have been slightly negative. It seems its ok, we may be missing something. SCADA has not been totally reimbursed. Possibly why the cash balance has gone down.

CABLE

Greg reports they are not able to broadcast. Still waiting for the computer system to get up and running.

SEWER

Nothing else.

GAS

Gas Line project-

Long Lake project- Pam emailed and said she is seeing a lot of places that are not homes, so I suggested she might do a pre sign up.

STREET LIGHTS

Foreman Jurenic is concerned with the three street lights on Shady Lane, lens are discolored. Also, would like MPL to cut the tree branches over the light. Tony says we have to pay for repairs. Dennis says the one on Woodlawn Circle is burnt out. We will check it out and make a call to MPL to see if they will trim the branches, otherwise Al will have to do it.
