Guests were Town Board Chairman Tony Tammaro, Gina Brascugli and Sandra Walher.

APPROVAL OF MINUTES

• Motion to approve the Regular PUC Meeting Minutes of March 12th, 2024, made by Commissioner Eugene O'Brien and supported by Dave Hamalainen. Motion carried unanimously.

SCHEDULED GUESTS- None at this time.

CORRESPONDENCE

<u>Delinquency Reports</u> – Chairman Tammaro made mention that there were a few new names this month. <u>March Water/Wastewater Report</u> – Did not have one, Rick has been out sick.

OLD BUSINESS

St. Mary's Lake Development - Still waiting on more information from Developer.

EPA Lead and Copper Survey – There are only about 25 surveys that need to be returned.

<u>Sump Pump Survey</u> – Surveys are being returned, but slowly for this one. Chairman Vest inquired about the line by St Mary's Lake, stating that would be a good candidate for replacement. Chairman Tammaro asked if there is a trend in sump pumps running a lot more now? Hiti responded she would ask Rick Bieganek.

<u>Differding Point Waterline Increase/Ownership Transfer</u> – Chairman Vest commented that our residents do not have Gilbert's new meter. Commissioner Erickson commented that in fact we are a bulk customer and should be billed as a bulk customer. All agreed. 2004 is the last water contract we have from Gilbert and it clearly states Fayal is a bulk customer.

NEW BUSINESS

<u>Special PUC Meeting April 16th at 6:00pm – Fayal Town Hall</u>- Clerk Coldagelli sent letters to invite the Differding Point residents affected by this water increase.

Mn Power Tree Trimmers - Comments made they are rutting up the right of-ways.

Treasurer's Report – March balances are as follows:

Fayal Water Company- beginning balance was \$33,626.60. Revenues were \$6,843.14 and expenditures were \$7,592.02. Ending cash balance was \$33,148.61 and depreciation not in the 4M Fund was \$1,082.70.

Fayal Sewer Company- beginning balance was \$229,454.15. Revenues were \$58,876.67 and expenditures were \$52,731.57. Ending cash balance was \$236,471.53. Depreciation 4M was \$201,710.01.

PUC Truck Depreciation 4M was \$37,404.99. Assessment Savings 4M \$256,046.20. Sewer Access Charges 4M \$76,025.01. Maintenance Contingency 4M \$33,118.06. PUC- beginning balance was \$2,262.17, Revenues were \$0, and expenditures were \$3,746.52, for an ending balance of \$1,171.32. Discussion regarding interest rates and where it goes to? Chairman Vest asked about where the interest money is to be allotted to? Both companies are looking good.

• Motion to approve the Treasurer's Report, made by Commissioner Dave Hamalainen and supported by Eugene O'Brien. Motion carried unanimously.

Next PUC meeting to be held on May 14th, 2024 at 6:00 PM. Commissioner Hamalainen will not be-able to attend this next meeting.
